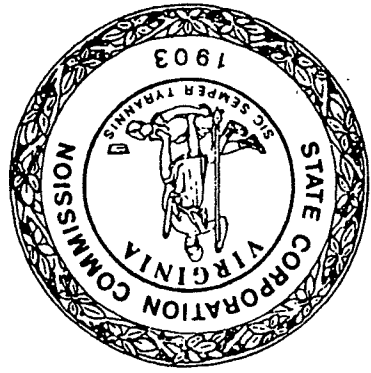

ARTICLES OF INCORPORATION

OF

BAYBERRY COVE PROPERTY OWNERS ASSOCIATION, INC.

I hereby associate to form a non-stock corporation under the provisions of Chapter 10 of Title 13.1 of the Code of Virginia, and to that end set forth the following:

(a) The name of the corporation is Bayberry Cove Property Owners Association, Inc.

(b) The purpose for which the corporation is organized is: To establish a homeowners association for the homeowners in the subdivision known as Bayberry Cove.

(c) The corporation shall have members who shall be fee simple owners of the building lots in the Bayberry Cove Subdivision which members shall have voting rights.

(d) The directors of the corporation are to be selected in the following manner: All fee simple owners of building lots at Bayberry Cove Subdivision shall be members of the Bayberry Cove Property Owners Association, Inc. The members of the Association shall elect the directors of the corporation by majority vote.
